RULES AND REGULATIONS FOR THE R.E.S.D.A. FUTURITY

ENTRANCE REQUIREMENTS

1. Entries must not exceed 3 years of age on January 1, 2019. This means they must have been born on or after January 1, 2016, and not before this date.
2. Owners and Handlers must be members of R.E.S.D.A. Membership Fees \$25.00
3. Entries on the Futurity shall not have been shown in a contest of any kind prior to the Futurity.
4. An owner may enter more than one dog and/or handler may handle more than one dog.
5. Each dog will have two runs and highest combined score will win the 2019 futurity.
6. Scoring: R.E.S.D.A. Open course rules
7. Sheep will be the same as those run on 21st for the Potter Valley Trial.
 - a. Sheep may be rerun for Run 2 of futurity.
8. AWARDS: Prize money less expenses split 40-30-20-10
9. Entry fee for each dog is \$100.00
 - a. Postmark Due \$50 Aug. 16, 2019
 - b. Postmark Due \$50 Sept. 14, 2019
10. All progressive payments made on or before the due date are final. No refunds can be made, except in cases when the entire nomination fee is pre-paid. In such cases, the unused portion of the fee will be refunded if the dog is scratched.
11. All checks for entry and other fees will be made payable to R.E.S.D.A. Payments must be postmarked by midnight of due date or a late penalty of two times the amount will be assessed.
12. Late entries will be accepted. Late fees will be \$25.00, plus payment of remaining fees (if any) will be assessed.
13. Substitution of handlers due to accident or illness during the Futurity will be subject to approval from the R.E.S.D.A Board of Directors. The Boards decision will be final.
14. Change in ownership: If any entry changes ownership the entry will retain eligibility by complying with the following steps:
 - a. Notification of change in ownership and the intention of the new owner to continue the entry.
 - b. Payment of remaining fees when due.
 - c. The New owner becoming a member of R.E.S.D.A
